HOTEL ACCOMMODATIONS: A block of rooms is available at the Hampton Inn-Gateway Arch for those who require overnight accommodations. The government rate for a single room is \$150 plus tax. Or you can call the hotel at 314-621-7900 and refer to Upper Mississippi River when making your reservations. The cut-off date is Saturday, October 7th.

AIRPORT TRANSPORTATION: Three options if not renting a car:

1) Metrolink is \$2.50. Exit the train at the 'Convention Center' stop at 6th Street and Washington Ave. Continue walking 2 blocks east to the hotel at the corner of 4th Street and Washington Ave.

- 2) Uber and Lyft are available.
- 3) Taxi is about \$30.00 each way.

PARKING: Overnight hotel guests: \$30 per day, per vehicle, with in & out privileges for Upper Mississippi River overnight hotel guests, who must check in first to get a room key and use the room key to enter the parking garage. Hilton Honors Guests - Digital Check-In and Digital Key are available at this hotel through your Hilton Honors App. With your digital key, you can park and go straight to your room without obtaining a parking key.

Meeting attendees not staying overnight at the hotel have two options:

Option 1) Daily parking at the rate of \$8. Come into the lobby to the front desk and inform the agent you are here to park for the Upper Mississippi River meeting. They accept cash or credit card.

Option 2) Early Bird special at the rate of \$10: Park across the street at MAC (Missouri Athletic Club) if you arrive before 9:00 a.m. and leave after 3:00 p.m. They accept \$10 cash only.
